**Work as a local Councillor** *Councillors have identified the work undertaken on behalf of local constituents. Including any major initiatives or special projects they have been associated with on behalf of CCC, which have a direct impact on local constituents.*

My portfolio is of Finance, Procurement and Public Protection. This includes working with officers and departments within the authority dealing with these issues and also includes representing Ceredigion when working with other Local Authorities and Welsh Government.
