

The Council proposes to make the Ceredigion County Council (Prohibition and Restriction of Waiting and Loading and Unloading) Order 2019 (Morgan Street, Cardigan) (Amendment Order No.8) 2023. The effect of this is to replace 5 limited waiting bays on the eastern side of the junction between Morgan Street and St Mary Street with pedestrian footway, a flood alleviation pumping station and to increase the length of the limited waiting bay on the southeast side of Morgan Street that is south of the junction with Pwllhai from 13.9 metres to 17.9 metres.
